

It is our pleasure to welcome you to the **76th Annual Congress of the International Institute of Public Finance, held at the University of Iceland, Reykjavík.**

Reykjavík is Iceland's capital city and is by far the largest community in Iceland, with a total population (including the neighbouring towns) of about 200,000, which is about 60% of Iceland's population of 360,000 people.

Despite being a relatively small city Reykjavík has a bit of a metropolitan vibe with a surprising variety of cultural and social happenings as well as an abundance of trendy restaurants, cafes and bars.

It's a great place for a city break and makes an ideal base of operations for going on day tours of nearby regions such as South Iceland or the Snæfellsnes Peninsula.



The International Institute of Public Finance

The International Institute of Public Finance is the world organisation of public finance economists, comprising approximately 750 members from over 50 countries. In an increasingly specialised academic field, the IIPF seeks to generate intellectual interchanges among public finance experts.

The Institute's annual congress is the main forum for its activities, which include organising academic events, promoting the exchange of knowledge between academics and practitioners of all nationalities, and awarding prizes for outstanding academic achievements. The congress also provides an opportunity for the IIPF governing bodies (Board of Management, General Assembly of Members) to convene.

The IIPF is currently administered by an Executive Committee consisting of President **Clemens Fuest** (ifo Institute and University of Munich, Germany) and two Vice Presidents: **Katherine Cuff** (McMaster University, Canada) and **Wojciech Kopczuk** (Columbia University, USA). The legal and administrative seat of the non-profit organisation is in Munich, Germany.

Congress Venue: University of Iceland, Reykjavík

The congress will take place at the University of Iceland's main campus, in the heart of Reykjavík the capital of Iceland. The venue is about 10 minutes walk from the centre of Reykjavík and is accessible via various transport routes including bus and taxi. All conference hotels are located within walking (or public transport) distance to the campus.

How to get there

Iceland is situated in the middle of the Atlantic Ocean, midway between Europe and North America, and is easily accessible with high frequency of flights to and from the country. International flights arrive at Keflavik Airport, located 50 km south of Reykjavík city. Reykjavík has a public transport system and local taxis are also an option between locations.
