ABOUT THE IIPF

The aims of the Institute are the study of Public Finance and Public Economics, research in these fields, and the establishment of contacts and exchange of opinions on these issues among persons of all nationalities. The IIPF has around 800 members from almost 60 countries. In an academic field that is becoming increasingly specialized, the IIPF seeks to generate intellectual interchanges among all who research, teach or practice in the areas of Public Finance and Public Economics. Members are from universities and the civil service, from industrialized as well as developing countries. The major activity of the Institute is its annual Congress in which the IIPF promotes academic debates and exchanges of opinions on topics of common interest, and contributes to the worldwide dissemination of the results of scholarly work and of practical experiences.

The current IIPF President is Robin Boadway, Queen's University, Canada. He is assisted by two Vice Presidents: Michael P. Devereux, University of Oxford, UK, and John D. Wilson, Michigan State University, USA.

THE VENUE & SURROUNDING AREA

Located at the southern edge of the University of Michigan's Central Campus, the Ross School's facilities encompass a new 270,000-square-foot building that will host the Congress. The welcome session and plenary sessions will take place in Blau Auditorium, while the scientific sessions will be held in the state-of-the-art classrooms.

Ann Arbor is the State of Michigan's seventh largest city with a population of about 115,000, of which 41,000 are university or college students. The University shapes Ann Arbor's economy significantly as it employs about 39,000 workers, including 14,000 in the medical center. The city's economy is also centered on high technology, with several companies drawn to the area by the University's research and development activities, as well as its graduates.

Visitors are attracted to Ann Arbor for its eclectic urban setting and acres of parks and trees. The cosmopolitan college town boasts fine to casual dining and world-class shopping in nationally known stores and boutiques with local flair. Cultural experiences, including museums, galleries, and performing arts centers, make Ann Arbor a destination for arts aficionados.

The city of Ann Arbor is easy to reach by plane or car. The city's center is only 30 minutes from Detroit Metropolitan Airport. The city of Detroit provides additional benefits as a potential site for excursions and sightseeing.
